1 INTRODUCTION AND INTERPRETATION

1.1 Introduction

These Program Regulations apply to all students enrolled in the Master of Arts - Philosophical Studies (Coursework) Award at The University of Notre Dame Australia.

These Regulations should be read in conjunction with the University's General Regulations and the School of Philosophy and Theology Regulations.

1.2 Interpretation

The terms included in these Regulations have the meanings as defined in the University's General Regulations and the School of Philosophy and Theology Regulations.

1.3 Amendments made to Program Regulations

Unless otherwise specified, when amendments are made to the structure, content or academic requirements of this Award, the amendments will automatically apply in accordance with General Regulation Section 1.7.

1.4 Applicability to Campuses of the University

This Award is available on the Fremantle and Sydney Campuses only.

1.5 The Australian Qualifications Framework (AQF)

The Master of Arts - Philosophical Studies (Coursework) Award is not an AQF qualification.

2 ENTRY CRITERIA

2.1 General Criteria

The standard entry requirements for admission are detailed in the University's General Regulations and the School of Philosophy and Theology Regulations.

2.2 Additional Entry Requirements / Pre-Requisites

The following entry requirements apply to this Award:

Applicants are required to have completed a Bachelor of Philosophy (or equivalent) or an undergraduate degree in another discipline

2.3 External Accreditation Requirements

External accreditation requirements are not applicable to this Award.

3 AWARD REQUIREMENTS

3.1 Structure

For the Master of Arts – Philosophical Studies (Coursework), refer to Appendix A.

3.1.1 Compulsory Courses

One (1) 6000 level course is required in either Ethics or Theology (on the Fremantle campus). PHTH6002 Reason and Revelation (on the Sydney campus).

3.1.2 Elective Courses

There are Elective course(s) within this Award.

In addition to the compulsory course outlined in 3.1.1, students enrolled in the Master of Arts – Philosophical Studies (Coursework) must successfully complete a further one hundred and seventy five (175) units of credit or seven (7) courses in Philosophy taken at 6000 level.

3.1.3 Majors and Double Majors

There are no Majors available in this Award.

3.1.4 Minors

There are no Minors available in this Award.

3.1.5 Specialisations

There are no Specialisations permitted in this Award.

3.1.6 Special Interest Courses

There are no Special Interest Courses in this Award.

3.2 Special Award Requirements

There are no special award requirements in this Award.

3.3 Practicum or Internship requirements

There are no Practicum or Internship requirements in this Award.

3.4 Approved course substitutions

Course substitutions, where permitted, must be approved by the Dean.

3.5 Alternative Pathways

3.6 Volume of Learning

3.6.1 Standard Duration

- (a) The standard duration for this Award is one year of equivalent full-time study.
- (b) A student is able to enrol in this Award on a part-time basis.

3.6.3 Maximum Duration

The maximum period of time within which a student is permitted to complete this Award is 5 years (including any periods of approved leave of absence) from the date on which they were first accepted into the program by the University.
